plate" and represented our project. The document authorizes a \$1,514,752 advance on the Preliminary Apportionment of \$8,502,512 approved at the State Allocation Board meeting on May 28, 2008. Just as the full apportionment, the advance will be funded as 50% grant/50% loan, with loan payments initiating 1 year after occupancy.
