- 4. Vote to Approve Minutes for May 20<sup>th</sup>, 2009 & June 17<sup>th</sup>, 2009
  - Motion to approve minutes from May 20<sup>th</sup> by Denise. Seconded by James. Unanimously approved.
  - Motion to approve minute from June 17<sup>th by</sup> Caleb. Seconded by Erik. Unanimously approved.
- 5. Presentation of YRCS budget for 2009-10
  - Presentation by Caleb. There were even more summer budget cuts. The spring cut was nearly \$100k. During the summer the Governor reduced the budget another \$60k. We had a budget rollover from last year and also minimized cuts by taking one-time Stimulus Funds money. Our current school year is also being reduced by 5 days. May 27<sup>th</sup> last day of school. To sum it up: YRCS employees took a one week pay cut.
- 6. Annual Fund Drive
  - Presentation by Melissa. This year's appeal letter will be written by Jilan & Joe Glorfield.
  - Items to consider in and for the appeal letter:
    - i. Under Twin Ridge's School District our per-student ADA was \$7200. It has been cut down to \$4700 per child as of this current year.
    - ii. Without any community gifts or donations our annual operating budget is \$1.6 million. This past year alone the school took a \$200,000 in total budget cuts. On top of this we, as a charter school, have to pay for our own facilities rental, unlike other public schools.
    - iii. Attendance = \$\$. Each day any child is out of school, our school is deducted about \$35 (TBC)in ADA monies.
    - iv. The cost of YRCS to educate each child each year is approximately: TBD (\$7500?)

### 9. Revamping the Capital Campaign

## 10. Update on Stimulus Fund Development

- After the many inquiries, contacts, letters, and much persistence, it comes down to YRCS not being able to qualify for any stimulus funds due to the debt load the \$4.25 million we have already been granted.
- Denise: Melissa & Denise went to RSF Social Finance to meet with Don Shafer and John Bloome. They are not in the position to introduce us to their donors or investors. We need to get the word out about our project so "they" learn about us and then potentially could inquire with RSF.
- Melissa has a call due to California Charter School Associate to receive support for PR & media.

## 11. Update on Grant Writing:

- Melissa & Kwong (YRCS Grant Guru & Grant Visionary"): We need to meet with Shawn Garvey to revisit our conversations from last May. This should happen when everyone is available (i.e. Melissa, Kwong, Denise, Kim, Kateri, BJ)
- \$3500 was added to existing budget last year for grant writing. This money is still available.
- Kwong would like to see the EF mission focus more on going for grants. (Curriculum grants: agricultural, music, etc.)
